# Vote #2020-9

## **General Managers Report:**

#### Covid-19

GM Kowalik informed the Commission of the measures being taken by MMLD to mitigate the spread of the virus among MMLD employees and the public which includes rotating schedules for all 22 employees, social distancing within the plant and the closure of the offices to the public. He will continue to closely monitor the pandemic and adhere to guidance provided form Governor Baker's Administration.

## Village 13 Substation:

GM Kowalik informed the Commission due to unforeseen project site concern and the impact of the Coronavirus pandemic on normal department operations, the Marblehead Municipal Light Department is electing to postpone the Village 13 project at this time.

#### **Tree Survey:**

GM Kowalik informed the Commission that MMLD contracted with Cicoria Tree service to identify and document tree/wire conflicts on selected high voltage circuits, including recommendations for tree removal and pruning to reduce the likelihood of service interruptions due to for switchgear and transformers. We anticipate that we will rebid later this year with the expectation of a 2021 delivery.

# **Causeway Light Poles:**

GM Kowalik informed the Commission that the new causeway light poles and fixtures will be shipped shortly. He will contact Town Administrator Silva to discuss splitting the cost.

#### **NREL:**

GM Kowalik will coordinate a late April meeting between MMLD, NREL and MMWEC to discuss NREL's preliminary results which utilized NREL'stool called REoptto evaluate the techno-economic report for the potential of adding PV, wind, and battery storage to offset MMLD's energy costs.
