- Must be purchased 1/1/2024 and 12/31/2024
- Applications must be postmarked by 1/31/2025 and mailed to the address above
- Do not mail with your utility payment
- If multiple tools purchased in a bundle, use 1 form per bundle; Check all tools in bundle
